A RESOLUTION OF THE TOWN OF MILLIKEN AMENDING THE TOWN'S COMPREHENSIVE FEE SCHEDULE TO ADOPT MARIJUANA BUSINESS LICENSE FEES AND LIQUOR LICENSE FEES FOR BREW PUBS AND DISTILLERY PUB LICENSES

WHEREAS, the Town of Milliken Board of Trustees has adopted retail and medical marijuana business licensing and zoning regulations in order to allow marijuana businesses to locate in certain areas of the Town; and

WHEREAS, the Town will be processing applications for marijuana businesses and expending significant staff resources to that end; and

WHEREAS, the Town Board of Trustees desires to adopt application, licensing, operating and other associated fees related to the Town's administration of the licensing program; and

WHEREAS, the Board further desires to adopt new liquor license fees and occupation tax for two new classes of liquor license to include brew pubs and distillery pubs; and

WHEREAS, by adoption of the fees set forth herein, the Town's Fee Schedule is amended to incorporate such fees.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF MILLIKEN, COLORADO:
