## DISCUSSION AGENDA

### **1. Review and Approval to Set Public Hearing for Accessory Structures**

Director Perkins asked the Commission to review the final draft of proposed changes to Chapter 16 of the Milliken Land Use Code as it relates to Accessory Structures. Perkins addressed the proposed changes made with the Commission. Perkins will review R-2 and R-3 zone areas for lot size and bring the revised draft back to the Planning Commission at the next meeting.

### **2. Review of Suggested Changes to the MU-C-D Zone District**

Director Perkins reviewed Staff's recommended changes to the Milliken Municipal Code Section 16-3-360 as it relates to Mixed Use Commercial Downtown District (MU-C-D). The Commissioners reviewed some of the changes and asked Director Perkins to bring the changes back colored in red for easier reading.

### **3. Update Regarding the Allowance of Bee's Within the Town**

Director Perkins informed and updated the Commission regarding the Work Session of the Milliken Town Board on July 13, 2016 for the Allowance of Bee's within the Town of Milliken. Director Perkins explained what the professors spoke about at the Town Board's Work Session and Commissioner Watson who attended the Work Session, expounded on some of the information provided, such as water needs and bee friendly plants.

Discussion from the Commission is regarding the direction staff should take, whether to leave the Code as it is, or to create an ordinance. The Commission requested staff to bring this question to the Town Board for direction.
