PARKS

PDC Energy is currently pulling the gas wells at Fitness, Florence and Frank Farms Park on the Westside of town. There will be a lot of equipment on these sites and a lot of work being done to the site. In order to ensure public safety, a temporary chain link fence will be installed around these parks. There will be some traffic and equipment movement during February and March to permanently close off these wells. Any damage to the parks turf/infrastructure will be repaired this spring by PDC energy. We are excited to not see these "eye sores" in our parks anymore. The Town thanks PDC Energy for taking the wells out and their contribution of \$ 75,000 to upgrade Frank Farms Park this coming year.

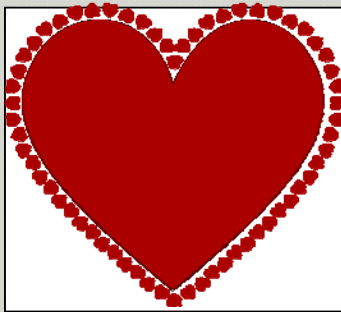
## WORD FROM THE MAYOR

## SPOTLIGHTS FOR FEBRUARY— SNOW REMOVAL



The Police department would like to remind residents of ordinance **11-1-20. - Snow and ice removal from sidewalks.**

The owner, occupant, lessee or person in possession or control of any premises or property shall maintain the sidewalks adjoining such premises or property, and shall remove and clear away, or cause to be removed or cleared away, snow

and ice from sidewalks in all business districts within the Town by four (4) business hours after the cessation of any fall of snow, sleet or freezing rain or by the beginning hours of the next business day following such fall, whichever period is shorter, and from all other sidewalks in the Town within twenty-four (24) hours of the cessation of any fall of snow, sleet or freezing rain.

## FENCE PERMITS

The Town of Milliken requires all new and repaired fences to get a courtesy permit at Town Hall. The permit takes 24 to 48 hours for land use approval. If you have any other questions please contact Caree at Town Hall today.
