## IRS SCAM

The Internal Revenue Service warns consumers about a sophisticated phone scam targeting taxpayers throughout the country. Victims are told they owe money to the IRS and it must be paid promptly through a pre-loaded debit card or wire transfer. If the victim refuses to cooperate, they are then threatened with arrest. In many cases, the caller becomes hostile and insulting. If you get a phone call from someone claiming to be from the IRS, here's what you should do:

- If you know you owe taxes or think you might owe taxes, call the IRS at 1-800-829-1040. The IRS employees that can help you with a payment issue- if there really is such an issue.
- If you know you don't owe taxes or have no reason to think that you owe any taxes (for example you've never received a bill or the caller made some bogus threats as described above), then call and report the incident to the Treasury Inspector for Tax Administration at 1-800-366-4484.
- You can file a complaint using the FTC Complaint Assistant; choose "Other" and then "Imposter Scams." If the complaint involves someone impersonating the IRS, include the words "IRS Telephone Scam" in the notes.

The Milliken Police Department would also ask that you never give out personal information whatsoever over the phone. As always please contact the Milliken Police Department at any time if you have any questions.
