TOWN HALLIrrigation Update

Just a reminder that winter is around the corner and according to Milliken Municipal Code Sec. 13-2-60(5) no automatic sprinkler irrigation shall occur between November 1st and March 1st of each calendar year. Now's a great time to start thinking about winterizing your sprinkler systems.









ATTENTION RESIDENTS

Sec. 11-1-10. - Repair and maintenance.

The owner, occupant, lessee or person in possession or control of any premises or property shall maintain the sidewalks adjoining such premises or property in good repair and in a safe, unobstructed condition, free of snow, weeds and debris. (Ord. 481 §1, 2003)

Sec. 11-1-20. - Snow and ice removal from sidewalks.

The owner, occupant, lessee or person in possession or control of any premises or property shall maintain the sidewalks adjoining such premises or property, and shall remove and clear away, or cause to be removed or cleared away, snow and ice from sidewalks in all business districts within the Town by four (4) business hours after the cessation of any fall of snow, sleet or freezing rain or by the beginning hours of the next business day following such fall, whichever period is shorter, and from all other sidewalks in the Town within twenty-four (24) hours of the cessation of any fall of snow, sleet or freezing rain. (Ord. 481 §1, 2003)

MILLIKEN COMMUNITY TRAILS SURVEY

The Thompson Rivers Parks and Recreation
District, municipal leaders, and local

develop a trail in southwest Weld County and

Currently an abandoned rail corridor south of Milliken is being considered for this purpose. Nearby natural and historic features, including the Wildcat Mounds, the South Platte River, the St. Vrain River, and Fort St. Vrain, would make it an ideal regional trail corridor. A trail in this location could serve as the spine of a regional trails network, eventually connecting Milliken to nearby communities such as Firestone, Mead, Platteville, or Berthoud, and bridging a gap in the state trail system. These existing amenities and potential connections would offer opportunities to attract visitors to local communities.
