WORD FROM THE MAYOR

One of the objectives of the Town Board is to promote economic development in order to diversify our tax/revenue and not to be solely dependent on personal property tax and oil and gas revenues. To achieve this we need to:

- Create a foundation and plan to pursue this objective.
- Give the town an opportunity to attract and keep businesses.
- Collaborate with other jurisdictions and the private sector.

The town has hired Walt Elish, an economic consultant, on a part-time basis (10-15 hours per week). Walt was a director of Northern Colorado Economic Development and currently works part-time for the Town of Berthoud. The ability to use a qualified, experienced professional in this capacity has tremendous benefits for the Milliken community. The ability to share his time between two smaller towns allows each to have a resource that would be difficult to replicate on its own. Walt is contacting property owners of commercial and industrial zoned property within Milliken and working with various county, regional, and state economic and community development organizations.

Additionally, various Board members and staff are members/directors of regional organizations such as North Front Range Metro Planning Organization (a regional transportation planning organization), Interstate 25 and Hwy 85 coalitions, and Upstate Colorado (an economic development organization in Weld County comprised of public and private sector leaders to establish quality development in the region). By communicating and collaborating with others in the region, Milliken can establish a strong foundation for its economic future.

SPOTLIGHT FOR JUNE

ALL HOME BUSINESSES NEED A BUSINESS LICENSE WITH THE TOWN

Registration is required for the maintenance, operation or conduct of any business or establishment or for conducting or engaging in any business activity or occupation. A person shall be subject to the requirement if, by himself or herself or through an agent, employee or partner, he or she holds himself or herself forth as being engaged in the business or occupation, solicits patronage therefor, either actively or passively, or performs or attempts to perform any part of such business or occupation in the Town. Building contractors are not subject to registration under this Article. When building contractors are registered through the provisions of Article IV of this Chapter, they shall also be registered as a business. (Ord. 685 §1, 2013)
