The Town of Milliken is currently in the process of updating the Envision Milliken Comprehensive Plan and needs your help! Join us for a Community Open House on October 7, 2015 from 7:00pm to 9:00pm in the Community Room at Town Hall (1101 Broad Street) to review a first draft of the plan. This draft plan draws from a series of stakeholder interviews, public meetings, and online surveys held over the past 10 months and will be used by the Town and public officials as a guide for future development and land use decisions in Milliken over the next ten to twenty years. At the Open House, you will be able to learn about the goals, policies, and implementation strategies contained in the plan, review an updated future

WORD FROM THE MAYOR

The Town Board has recently approved the final plat and development agreement with Two Rivers Park and Recreation (TRPR) district. Construction has started on the recreation field house and soccer complex located south of the school administration building.

The TRPR project is on schedule to be open in April 2016. The parking lot area and soccer fields will be completed in the next four weeks. There will be two full size soccer fields/football fields with parking spaces for over 200 vehicles. TRPR plans to have spring soccer prior to opening the new facility. The steel structure will be delivered in late September and the building should be completely enclosed by Christmas. The building itself will be 21,500 sq. ft. with basketball/volleyball courts, a workout room, three rooms for the Boys and Girls Club, and TRPR administration offices.

Starting with conversations in early 2014, this project exemplifies how a collaborative effort by TRPR, The Boys and Girls Club, and the Town of Milliken is able to realize amenities for our area. By understanding each other's needs, having common goals, strategically planning, and pooling resources, the entire community will have facilities, which will be of a long-term benefit for residents and businesses of Milliken.
