Town of Milliken Community Trail Survey, Please Take Part

The Town of Milliken is conducting a Community Trail Survey and wants your feedback. To take the survey simply go to the Town of Milliken's homepage at <http://www.millikenco.gov/> and scroll down to the heading, "We want to hear from you!" The Town in February of 2014 received a Walk and Wheel Grant from Kaiser Permanente in the amount of \$100,000. This funding is being utilized to conduct a community wide survey to determine what actions Milliken can take to better improve trail interconnectivity throughout Town and to hire a consultant to complete a Gap Analysis of the Town's existing trail system. The grant also provided funding for Milliken's engineering and design work for Milliken's portion of the Johnstown - Milliken Trail

which will run along on Weld County Road 46 1/2 from the edge of Green Street to Weld County Road 19. The Johnstown section once completed will extend the Milliken-Johnstown trail to Weld County Road 17 and finalize the trail connection between the two Towns.

The Town of Milliken and the rest of the nation are suffering more from an inactivity phenomenon rather than an obesity epidemic. That is why trails are so important to Milliken and its surrounding communities. So, please go to the Town's home page and take the survey. Your feedback is needed to shape the community's trail system.

SPOTLIGHTS FOR JANUARY

Snow Removal

According to Sec. 11-1-20 of the Milliken Municipal Code:
The owner, occupant, lessee or person in possession or control of any premises or property shall maintain the sidewalks adjoining such premises or property, and shall remove and clear away, or cause to be removed or cleared away, snow and ice from sidewalks in all business districts within the Town by

four (4) business hours after the cessation of any fall of snow, sleet or freezing rain or by the beginning hours of the next business day following such fall, whichever period is shorter, and from all other sidewalks in the Town within twenty-four (24) hours of the cessation of any fall of snow, sleet or freezing rain. (Ord. 481 §1, 2003)
